#### Purposes of the processing of personal data of the Data Subject:

The purposes of the processing of personal data of the Data Subject are as follows:

- a) processing accounting documents
- b) keeping records of clients for the purpose of concluding and fulfilment of contracts
- c) archiving documents in accordance with the legal regulations
- d) claims

#### Legal basis of the processing of personal data of the Data Subject:

The legal basis for the processing of personal data of the Data Subject will be depending on the specific personal data and the purpose of its processing, the consent of the Data Subject to the processing of personal data, fulfilment of the legal obligation of the Controller, fulfilment of the contract by the contracting party, who is the Data Subject.

Specification of the legitimate interests pursued by the Controller or a third party: Not applicable.

#### Recipients or the categories of recipients of personal data:

The recipient of personal data of the Data Subject will be or at least may be (i) statutory bodies or members of the statutory bodies of the Controller and (ii) employees of the Controller (iii) business representatives of the Controller and other persons cooperating with the Controller while fulfilling tasks assigned by the Controller. #### **Storage period for personal data:**

- h) the right of the Data Subject related to automated individual decision making pursuant to Article 22 of the Regulation,

## Advice on the right of the Data Subject to withdraw their consent with the processing of personal data:

The Data Subject may at any time withdraw their consent to the processing of personal data without prejudice to the lawfulness of the processing of personal data based on consent granted prior to such withdrawal. The Data Subject may exercise their right to withdraw consent to the processing of personal data in writing to the address of the Controller registered in Commercial Register as its registered office at the time of withdrawal of consent to the processing of personal data or in electronic form by electronic means.

### Advice on the right of the Data Subject to lodge a complaint to the supervisory body:

The Data Subject has the right to lodge a complaint to the supervisory body, in particular, in the Member State of usual residence, the place of work or the place of the alleged infringement, if they consider that the processing of personal data concerning them is contrary to the Regulation, without prejudice to any other administrative or judicial remedies.

# Information on existence/non-existence of the obligation of the Data Subject to provide personal data:

The Controller will inform the Data Subject that the provision of personal data by the Data Subject is neither a legal nor a contractual requirement, neither it is a requirement needed to conclude a contract with the Controller. The Controller will inform the Data Subject that the Data Subject is not obliged to provide personal data neither is obliged to grant a consent to its processing. A failure to provide personal data and/or a failure to grant a consent with the processing of personal data will imply that the Controller will not process personal data and such personal data will not be used for purposes listed in point D of this document.
